Stir and apply with a putty knife.Push UGL 222 LITE firmly into hole or crack, smoothing the material with long strokes of the putty knife. For extra-smooth finish,lightly smooth patched area with a wet putty knife.

UGL 222 LITE can be painted almost immediately with latex paint. Before applying an oil-based paint, allow material to dry thoroughly. For best results, prime patched areas. Allow these areas to dry thoroughly before sanding.


